This form is for those active attendees of a host UMC church, who are not yet church members, but wish to show their qualification to play in the GDUMRA League. By signing this form, the pastor of the host UMC church is verifying this player's active participation in the four approved activities at least 50% of the time prior to November the 1st of the current season's year. See the following GDUMRA By-Laws for an expanding explanation.

- All players must be active as church members or as active participants in the worship service, CovKids, RISE, and /or choir.** Participation is defined as 50% of any one activity. An active participant does not qualify simply by being involved in the recreational aspects of the youth fellowship, such as a basketball team or scout troop. Rather to qualify, one must be involved in the regularly planned spiritual program of the youth fellowship.
- A player's participation should have begun prior to November 1. A player may qualify after November 1, only if he/she moves into the sponsoring church's neighborhood and joins the church or one of its activities during the league season. Upon the approval of the Executive committee, they may be added to the team roster of the sponsoring church.
- The minister's and coach's signature on the official entry form certifies that these standards are being met.
